District Council Report

Local Plan to be reviewed

The Liberal Democrat/Labour/Green and Independent coalition has voted to review the local plan. This will include gathering evidence to determine, amongst other things, how many extra homes Arun will need to accommodate. The papers suggest that Arun will need to test up to an extra 11,250 homes across the district, subject to evidence of constraints, including infrastructure. However, local examples suggest this will have a limited impact on the 11,250 figure.

I'm certain there will be many Bersted residents will be unhappy about this and I will ensure the administration are held to account for this decision.

Bersted Brooks Park Masterplan consultation – 15th July

The masterplan was available to view at Bersted Community Centre on Saturday 15 July 10am to 12.30pm.

Turnout at the event was good. It was a great opportunity to listen to local residents' concerns. A revised masterplan will be presented to the Environment Committee in September.
