I come to Full Council tonight hotfoot from a proper drenching at a site visit early this morning! February has been a busy month culminating in three meetings - The Special Council to agree the budget, The Arun Flood Group held at our own Bersted Community Centre and a Business Forum discussing flooding on the 29th February. At the Special Council meeting the budget passed unopposed, although next year will see more savings needing to be identified as we reduce our reliance on diminishing reserves . The Arun Flood Group was very well chaired and was a success despite the auditory problems presented by the venue which impacted heavily on the sizeable audience.

On Tuesday 5 March I attended a briefing on Cleansing contracts where the government's 'Simpler Recycling ' reforms were explained with the introduction of weekly collections of food waste which will be required from 01 April 2026. As it happens, the new Combined Cleansing Services' Contract has to commence on the 1st February 2026 with proposed weekly food collections and fortnightly residual and recycling collections with decisions to be made regarding provision of 180 or 240 litre capacity bins .

On the 6th March I chaired a Special Planning Policy meeting where we agreed minor amendments to the Direction of Travel Document as part of reviewing The Local Plan.
