Whilst being fully supportive of devolution of powers per se from Whitehall to Local Government, any reorganisation of current governance should follow a period of proper consultation with resident, businesses, elected representatives and stakeholders. This is in fact the very opposite to what the Government is doing, advancing change at seemingly breakneck speed, a pace of delivery which many of us deem inappropriate. How many people are fully au fait with the prospect of their district and borough councils being abolished by either 2027 or 2028? This reality is testament to the lack of any consultation with residents, the very people at the cutting edge of all local council services. Reorganisation was not explicit in The Labour Party's manifesto, so we have to question what mandate they have for its imposition, a radical change which could have unforeseen consequences for both residents and businesses alike. There is also the inherent danger that locally connected representation will be lost, thus creating a democratic deficit!

The cost of the proposed reorganisation has not been set out, but just realigning different IT systems as councils amalgamate in a unitary authority will take years and any savings will be a long time coming! There seems to be a clear disconnect between Central Government and Local Government and one has to fear for the sense of identity that could be diminished in any transition to unitaries where Councillors will have more residents to look after in their area.

As for postponing County Council elections this May, we wish to reiterate that this is not a prerequisite for inclusion on the priority programme for the formation of a strategic authority across Sussex. People elect councillors for a set term, so extending this by one to maybe three years completely disenfranchises the electorate, so West Sussex County elections should proceed unfettered in May.
